2012 Membership Dues Now Paid Conveniently Online

It's time to renew your SOFE membership! SOFE 2012 dues are conveniently paid online at www.sofe.org. It's as simple as 1-2-3!

- 1. Log into the Members Only area link at the upper right tab of the SOFE website.
- 2. Then click on "Renew Your Dues".
- 3. Once you have submitted your payment information, print your receipt for your records or to use for reimbursement purposes.

If you have forgotten your username and password information, follow the instructions at the Member login area. Please be sure to safe-list (and/or add to your contacts) sofewebmaster@sofe.org in order to receive a reminder of your login information. Do not create a new account, as that will not access your correct record.

2012 Membership Dues payment information was emailed in October. If you missed your announcement, safe-list (and/or add to your contacts) sofe@sofe.org and sofewebmaster@sofe.org in order to receive SOFE updates, as well as your online transaction information.

If paying by check, login to the SOFE website to see your dues amount and then remit a check with full payment to SOFE, C/o Wells Fargo Bank, Lockbox #759265, Baltimore, MD 21275-9265. To receive correct credit for payment, you must submit with your payment: a clear record of your name, your member number, your email address, and note that the payment is for "SOFE 2012 Dues".

NOTE—Dues for 2012 must be paid in full by January, 2012.

CRE REPORTING FORMS DUE

Please be reminded that the 2011 CRE Reporting Forms are due on March 31st, 2012. There is a \$25 late fee that will be applied to those received after March 31st. Failure to file the CRE Reporting Form on time may result in suspension of your designation. CRE AUDITS

All members with a designation have the possibility of being selected for an audit of your 2011 CRE

Reporting Form. In 2010, the SOFE Executive Committee approved a new procedure for performing CRE audits as follows: A random audit of 5% of all general members CRE Reports will be performed annually. A 100% audit of new Board of Governors' CRE Reports will be performed their first year in office, and a random sample of 20% of existing Board of Governors' CRE Reports will be performed each year. Questionable and incomplete CRE reporting forms will be audited at 100%. If you have any questions, contact the SOFE staff at sofe@sofe.org.
