SPONSORSHIP AGREEMENT FORM DEADLINE

The Sponsorship Agreement form is due by February 25th, for recognition in the SOFE 2013 CDS Registration Brochure and in the final program. The details and Sponsor Agreement form for the 2013 CDS Sponsorship program are linked on the SOFE home page, www.sofe. org.

CDS SCHOLARSHIPS

The Financial Examiners Education Foundation

has provided SOFE with scholarship funds for a limited number of attendees for the 2013 CDS. These scholarship funds are intended for state and federal insurance regulators whose department or agency does not cover the cost of attending SOFE's CDS. The scholarship applicants must be insurance regulators employed directly by a state, US territory, or federal government agency (i.e. contract examiners are not eligible). Applicants must be a member of SOFE in good standing. The scholarship funds cover the program registration fees only. Written evidence of the fact that the governmental agency does not pay for CDS attendance must be provided by the person in charge of the state or federal agency or his/her designee. Applicants with the AES, AFE or CFE designation and first time attendees will receive priority consideration, should there be more applicants than can be accommodated. All applications are due by April 30, 2013. Applications and information will be posted on the CDS website in March.

LATE REPORTING FOR 2012 CRE CREDITS DUE MARCH 31, 2013

CRE Reporting for 2012 was due online by January 31, 2013. Late reports are accepted via the Late CRE Reporting Form with the late filing fee until March 31. Failure to file the required credits is grounds for suspension of the designation The minimum number of CREs an examiner must earn in any one year is 20, except in the year the designation is received, when credits are prorated. HAVE YOU PAID YOUR SOFE 2013 MEMBERSHIP DUES? IF NOT- READ THIS!

SOFE bylaws call for suspension of members not paying dues by the end of March in the current dues year. This affects the SOFE designation as well. Only certified or accredited members in good standing can use the SOFE designation.

2013 Membership Dues payment information was emailed in October, November, December, January .and February. The \$15 late fee is now in effect for dues, but you may still pay your SOFE 2013 dues conveniently online at www.sofe.org. It is very simple:

- Log into the Members Only area link at the upper right tab of the SOFE website. (If you have forgotten your username or password information, follow the instructions directly under the Member login area for password or login retrieval)
- 2. Then click on "Renew Your Dues".
- 3. Once you have submitted your payment information, print your online receipt for your records or to use for reimbursement purposes.

Paying by credit card online is the best way to ensure your payment is received and credited by the final deadline, but if you must pay by check, login to the SOFE website to see and print out your dues amount and then remit a copy with a check with full payment to SOFE, C/o Wells Fargo Bank, Lockbox #759265, Baltimore, MD 21275-9265. To receive credit for payment, you must submit with your payment: either a copy of your online invoice or another clear notation of your name, your member number, your email address, and indicate that the payment is for "SOFE 2013 Dues". Mail your check by March 22 to ensure its delivery by March 29.

CRE AUDITS

All members with a designation have the possibility of being selected for an audit of their 2012 CRE reporting A random audit of 5% of all general members' CRE Reports will be performed annually. A 100% audit of new Board of Governors' CRE Reports will be performed their first year in office, and a random sample of 20% of existing Board of Governors' CRE Reports will be performed each year. Questionable and incomplete CRE reporting will be audited at 100%.
