#### **Report Your 2012 CRE Credits Online Now**

SOFE is pleased to announce that you can now report your CRE credits online! No more paper forms to complete and scan, mail or fax. Plus, you can input your CRE credit as you earn it and your current records will be updated automatically!

How to File:

First read the handy guide the Education Committee developed to assist you. You'll find this linked to the home page www.sofe.org

Then, log into the Members Only area of the SOFE website and click on the "Update Your Profile" link and scroll down to "Current

CRE Reporting Cycle Details" and hit the "add credits" button. Guidelines on the process are also with the online form.

If you have any questions after reviewing the Credit Reporting Guide or in using the site, please contact SOFE at sofe@sofe.org

Please remember that all 2012 CRE reporting must be completed by January 31<sup>st</sup>, 2013. An extension to March 31<sup>st</sup> may be requested if necessary; but the request for an extension must be received no later than January 31<sup>st</sup> and accompanied by a \$50 extension processing fee.

#### SOFE Renewal Due By January 31st, 2013

Dues for 2013 must be paid in full by January 31st, 2013. Dues are conveniently paid online at www.sofe.org.

To pay dues:

- Log into the Members Only area link at the upper right tab of the SOFF website.
- 2. Then click on "Renew Your Dues".
- Once you have submitted your payment information, print your receipt for your records or to use for reimbursement purposes.

If you have forgotten your username and password information, follow the instructions at the Member login area. Please be sure to safe-list (and/or add to your contacts) sofewebmaster@sofe.org in order to receive a reminder of your login information. Do not create a new account, as that will not access your correct record.

2013 Membership Dues payment information was emailed previously. If you missed your announcement, safe-list (and/or add to your contacts) sofe@sofe.org and sofewebmaster@sofe.org in order to receive SOFE updates, as well

as your online transaction information. It is best to pay online so that you have a receipt but if you must pay by check, login to the SOFE website to see your dues amount and then remit a check with full payment to SOFE, C/o Wells Fargo Bank, Lockbox #759265, Baltimore, MD 21275-9265. To receive correct credit for payment, you must submit with your payment: a clear record of your name, your member number, your email address, and note that the payment is for "SOFE 2013 Dues".

#### **CRE AUDITS**

All members with a designation have the possibility of being selected for an audit of your 2011 CRE Reporting Form.

In 2010, the SOFE Executive Committee approved a new procedure for performing CRE audits as follows:

A random audit of 5% of all general members CRE Reports will be performed annually.

A 100% audit of new Board of Governors' CRE Reports will be performed their first year in office, and

A random sample of 20% of existing Board of Governors' CRE Reports will be performed each year.

Questionable and incomplete CRE reporting forms will be audited at 100%. If you have any questions, contact the SOFE staff at sofe@sofe.org.
