Hello everyone!!! The 2009 CDS planning is well underway and we have an exciting program being planned for you. - 2. Meeting rooms We are still in the process of determining the number of classes and room requirements for each class, however, this year we have the hotel meeting space as well as the convention space available to us. The convention is right across the street and very convenient to our hotel. Once you pick your information packet at the registration desk, you will need to pay close attention to where your class will be held at. We are anticipating that the morning sessions will be held at the Convention Center while the afternoon sessions will be at the hotel. - 3. Event website We are utilizing the services of Sacramento Wine and Nightlife Tours and they have created a website just for us. See below for website address. These breakfast programs are open to all SOFE members and attendees of the NAIC quarterly meetings. There is no charge to attend and the attendee earns one (1) CRE credit.

The Executive Committee has approved a recommendation to increase the number of credits earned for passing each test of the CRE Reading Program from one (1) credit to two (2) credits effective with the Spring 2009 issue of the *Examiner*. That issue is currently being compiled by the Publications committee and will be available in early March.

The CRE Reading Program allows members to earn credit for reading the articles in the quarterly *Examiner* and then going online to the SOFE website to answer a series of between 12 to 15 questions about the articles. The questions are located at the front of each publication. (Note: Until the Winter 2008 issue, the questions were at the back of each publication.)

There is no cost to take the examination and you may continue to take it as many times as necessary to successfully complete it.

Several members approached the Executive Committee requesting that the credits given for each test be increased because it takes at least two hours to

thoroughly read each issue to be prepared to correctly answer the questions. After consideration of this request and based upon what other professional associations provide to their membership for similar programs, the Executive Committee approved the recommendation.

Therefore, effective in 2009 **each member can earn a total of 8 CRE credits annually** at no cost simply by reading the articles in the *Examiner* and taking the examinations, which are located in the Members section of the website.

To access the Members section, you must use your User Name (which is the first initial of your first name and your entire last name, all in small letters with no spaces) and your Pass Word (which is the membership number located on the membership card you receive annually. It may be necessary to add a leading zero to the membership number to make it a five-digit number.) If you have any problems accessing the Members section, contact Jeanne Lachapelle at jeanne@sofe.org.

Vaughn Named NAIC's New CEO

Former Iowa Insurance Commissioner Therese M. (Terri) Vaughan, Ph.D., has been named Chief Executive Officer of the National Association of Insurance Commissioners (NAIC), effective Feb. 18, 2009.

Vaughan replaces Catherine J. Weatherford, who left the NAIC in July 2008. Andrew Beal, who served as acting executive vice president and CEO in the interim, has been promoted to chief operations officer. Beal also will continue to serve as the NAIC's chief legal officer.

Vaughan will serve as the Association's primary representative and chief spokesperson in Washington, D.C. In addition, her responsibilities will include outreach to federal governmental entities and state government associations, as well as consumer and insurance industry representatives. She will also oversee the launch of the Association's new Center

for Insurance Information, which will make the NAIC information and resources more accessible to members of Congress and other federal agencies.

While the majority of staff members will remain in Kansas City, Vaughan's office will be housed in the association's Washington, D.C., headquarters. Vaughan will work alongside staff from the Interstate Insurance Product Regulation Commission (IIPRC). Vaughan is widely credited with being the architect of the NAIC's Interstate Insurance Product Regulation Compact.
