STATE CHAPTER NEWS

Alabama

Jack Marvin Brown has retired from the Department. He worked for the State of Alabama for 31 years and eleven months. Jack became a contract examiner with Alabama Department of Insurance on June 1, 1977. Jack was an employee of the Alabama Department of Revenue January 10, 1979. He also worked in the Alabama Department of Human Resources as a Food Stamp Auditor and the ABC Board as a Tax Auditor. On October 1, 1981, Jack returned to the Alabama Department of Insurance as an Insurance Examiner I.

From 1985 to 1986, Jack served as Supervisor and then served in the capacity of Deputy Receiver for the Commissioner of the Alabama Department of Insurance in the liquidation of Early American Insurance Company in Fort Worth, Texas. In the late 1980's Jack was instrumental in helping the US Attorney prosecute the two top officers of Champion Insurance Company, John Eicher Jr. and his son, Naaman Eicher. Both pleaded guilty to various federal charges and were sentenced to 46 months in prison and fined \$500,000 each by a federal district court judge. The Louisiana Insurance Commissioner, Doug Green, also went to prison because of information gathered from this examination.

On April 1, 1994, Richard Ford, Alabama Department of Insurance Chief Examiner promoted Jack to Assistant Chief Examiner, and he started a new career at the Department. Jack represented the Alabama Department of Insurance as the Society of Financial Examiner's (SOFE) Alabama State Chair from 2000 to 2003. In the summer of 2004, Jack received the Don Fritz Award from the Society of Financial Examiners for his outstanding service and dedication to the goals of the Society while serving as the 2003 - 2004 State Chair for Alabama.

During Jack's 30 years and 1 month of employment with the Alabama Department of Insurance he worked under 17 Insurance Commissioners and eight Governors of the State of Alabama. The employees of the Alabama Department of Insurance are going to miss Jack greatly. He was dedicated to helping his fellow employees by encouragement, fairness, and educating each of them. We hope he enjoys his retirement!
