CRE REPORTING FORMS DUE

Please be reminded that the CRE Reporting Forms are due on **March 31st**. There is a \$25 late fee that will be applied to those received after March 31st. Failure to timely file the CRE Reporting Form may result in suspension of your designation.

However, if you are planning to use the CRE Reading Program as the final 10 credits to meet the minimum annual requirement for 2010 there is an extended deadline of April 30th. After April 30th, there is a \$25 late fee.

CRE AUDITS

The SOFE Executive Committee approved a new procedure for performing audits of Continuing Regulatory Education Credits (CREs) at its meeting held on October 14, 2010. A 100% audit of new Board of Governors' CREs will be performed their first year in office, and a random sample of 20% of existing Board of Governors' CREs will be performed each year. A random audit of 5% general members' CREs will be performed annually. Questionable and incomplete CRE reporting forms will be audited at 100%.
