# **CRE Credits/Audit**

#### LATE REPORTING FOR 2023

#### Final Deadline: MARCH 31, 2024

The deadline to submit CRE Credits for 2023 was January 31, 2024. You have until March 31, 2024 to file late – any credit requirements met after the original deadline of January 31 are subject to a \$75 late filing fee. Failure to submit the required credits by March 31, 2024 is grounds for SOFE designation suspension.

# **CRE Audit**

All members with a designation have the possibility of being selected for the annual audit of the CRE credit hours they reported. Annual audit selections of reported CRE credit for the year are as follows:

- A random selection of 5% of all designees' reporting.
- One hundred percent (100%) of all questionable, late, or incomplete reporting.
- The CRE credit reported by all new members of the Board of Governors is audited in their first year in office.
- A random selection of 20% of the other Board members' CRE reporting for the year is audited.

# **Committee Corner: Nominations Committee**

#### **Committee Responsibilities:**

The Nominations Committee is responsible for nominating candidates to fill vacancies of expiring or open positions of the Board of Governors (BOG) and the Executive Committee (EC). The Committee identifies suitable candidates, and ensures they meet the qualifications to fulfill their duties required by the BOG and the EC. Nominations to the BOG can also occur through a self-nominations process.

#### **Committee Memberships**

The current Nominations Committee is comprised of six (6) members, and two (2) Co-Chairs, each of whom serves for a term of one year. Membership of the Committee is voluntary and meets on a periodic basis.

#### **Board of Governors and Executive Committee Qualifications:**

The BOG is the governing body of SOFE and consists of twenty-five (25) to fifty (50) members, each of whom serves for a term of five (5) years. The EC consists of twelve (12) to fifteen (15) members, each of whom serves for a term of two (2) years.

A member of the BOG must: 1) Be a certified member of SOFE, 2) Be elected by the membership, and 3) Be in attendance of at least 50% of board meetings.

A member of the EC must: 1) Be a certified member of SOFE, 2) Be a member of the current BOG, 3) Be elected by the BOG, and 4) Must attend at least six (6) quarterly meetings per two (2) year term (75%) to maintain eligibility for re-election).

#### **Current Openings and Voting Timeline**

Generally, the number of expiring terms of the BOG each year is ten (10), the number of expiring terms of the EC each year is seven (7) or eight (8), however, this number can vary based on term year. SOFE created this rotating term to prevent a stale BOG/EC and undue influence and promote new ideas for the direction of SOFE.

Currently, there are ten (10) members on the BOG, and four (4) members on the EC whose term expires in 2024. Voting occurs through an online election ballet. Any member of SOFE in good standing is entitled to vote. Notices are sent to members by SOFE's management company.
